### **CASE Study ONE**

#### NAKED ENERGY GOT COVERED

Solar installation can often be subject to delays which are completely unforeseen. These delays are beyond the control of the solar companies, for example, obtaining Western Power approval or making a required upgrade to surrounding infrastructure.

Nevertheless, the solar companies can find themselves being liable for these delays unless terms and conditions say otherwise. This means the solar company may be forced to pay compensation for as long as the delay prevents the solar installation.

Naked Energy, a Perth based solar company, decided it was time to update their customer contract terms and conditions. They contacted us as a full service legal provider to solar companies. We subsequently carried out a complete review of Naked Energy's existing contracts with customers.

## **CASE Study TWO**

#### SECURING FUTURE TENANTS CAN SEEM DAUNTING

Property development can often be contingent upon pre-commitment from future tenants. Total or substantial pre-commitments will often be required to obtain project funding and for any project to get off the ground. However, development requirements can be difficult to translate into legal documents because there are many variables to consider from time frames to building specifications.

Without comprehensive documents, it's difficult to secure those essential future tenants and, in turn, ensure that development funding can be secured.

Andrew Roberts was planning to undertake a custombuilt strata development comprising a building to accommodate two businesses; a workshop, warehouse and office for a building company and a fitness centre and café for the owners of a gym. Andrew contacted us with a view to draft the necessary documents to secure the future tenants. We discussed his development thoroughly and pulled together the documentation required.

The agreements for lease were complex and had to allow for many moving parts, particularly in relation to the strata title as the actual strata company does not exist until the building is complete.
